ORDER:

In the reference first read above, the name of the State Institution of Forest Training, Dulapally has been changed as A.P. Forest Academy, Dulapally. The A.P. Forest Academy provides specialized non-executive services such as, research, organizes training programmes and workshops for IFS officers from all over the country. It has been catering to the training nedds of not only forest officers and community members of A.P. but also of other States and countries as well.

- 2. After formation of new State of Telangana as per A.P. Reorganisation Act, 2014, the institution would continue to serve the State in which it is located and has to officer services/provide facilities to the other State through a Memorandum of Understanding.
- 3. The Principal Chief Conservator of Forests, Telangana State, Hyderabad in the reference third read above, has proposed to rename the "A.P. Forest Academy, Dulapally", located in the Telangana State as "Telangana State Forest Academy" and while sending the draft Memorandum of Understanding has requested to issue necessary orders in the matter.
- 4. Government, after careful examination of the matter in consultation with advisory departments under the provisions of the A.P. Reorganisation Act, 2014 has decided to rename the Andhra Pradesh Forest Academy as "Telangana State Forest Academy", keeping in view the educational activities and training programmes and workshop etc.. being conducted and organized by the said Academy. Accordingly, the "A.P. Forest Academy" is hereby renamed as "Telangana State Forest Academy".
- 5. These orders shall be deemed to have come into force with effect from 02.06.2014.
- 6. The Director, Forest Academy shall take further necessary action in the matter.
