ORDER:-

In the G.O.1st read above, Government have issued the "Telangana Forest Subordinate Services Training Rules, 2012" as amended from time to time.

2. In the circumstances reported by the Principal Chief Conservator of Forests, Telangana, Hyderabad in his letter 3rd read above, the Government, after careful examination of the proposal, hereby issue the following an amendment to Rule 14 of the Telangana Forest Subordinate Services Training Rules, 2012, issued in G.O.Ms.No.76, EFS&T (For.II) Department Dated:19-12-2016, regarding duration of training period to Forest Beat Officers/Forest Section Officers.

3. Accordingly, the following Notification shall be published in the Extraordinary issue of Telangana Gazette, dt.31-05-2019:

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and of all other powers hereunto enabling the Governor of Telangana hereby makes the following amendments to the Rule 14 of the Telangana Forest Subordinate Services Training Rules, 2012 issued in the G.O. 2nd read above.

AMENDMENT

In the said rules, for rule 14, the following shall be substituted, namely;

"The period of training for the Forest Beat Officer shall be 6(six) months and for Direct recruited Forest Section Officers six (6) months. In case of Forest Section Officer who are promoted from the category of Forest Beat Officer and who have already undergone six (6) months induction training in that category have to undergo three (3) months Orientation course. The training sessions shall be as follows:

- (a)FBO : (Six Months)
(b) FSO (DRs/Convertees) : (Six Months)
(c) FSO (Promotee) : (Three months)
